Whereas it is necessary in the interest of public safety and convenience I, Gyanwant Singh, IPS, Commissioner of Police, Bidhannagar, in exercise of powers conferred upon me U/S - 112 (2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 813-WT/3M-80/2002 dated: 09/03/2012 of Transport Department, Govt. of West Bengal, do hereby declare the following restrictive orders for No Parking and Towing Zones under Bidhannagar Commissionerate in c/w International Kolkata Book Fair, 2019 as per the following time schedule.

DATE AND TIME OF NO PARKING

31-01-2019
to
11-02-2019 } 10:00 hrs. to 22:00 hrs.

TYPE OF RESTRICTION

No vehicle will be allowed to Park on both the flanks of the following roads except authorized parking place and if parked, that will be towed immediately.

ROADS/LANES/AREARS

- i) Vidyasagar Island to J K Saha Bridge via Bhikharam Island, Indira Bhawan, Mayukh Bhawan, Central Park, Karunamoyee, 10 No. Tank Island.
- ii) 4 No. Gate of Salt Lake to Khalpar Road Via CA Island- AB & AMRO Island - Ramkrishna Island, Lalkuthi Island- Purta Bhavan Island- PCC Bhavan Island- 9 No. Island- CK Market.
- iii) 9 No. Island to Bidhannagar Municipal School Island via Karunamoyee.
- iv) 10 No. Tank to Laboni Island Via EE Island- Bidhannagar Municipal School Island- Netaji Island- Poura Bhavan Island.
- v) Mayukh Bhavan to Baisakhi Island via Purta Bhawan Island.
- vi) PCC Bhavan Island to Bidhan Chandra Roy Statue.

These restrictions will remain in force in addition to the normal restriction on the day which is not repugnant to above.
