ORDER

Whereas it is necessary for preventing danger, obstruction or inconvenience to the public in connection with the ID-UZ-ZOHA (Bakr-Id) festival on 12.08.19; T. Gaurav Sharma, IPS, Commissioner of Police, Howrah, in exercise of power conferred upon me w/s 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2002 of Transport Department, do hereby issue the following restrictive orders in the following manner prescribed below -

I. Restriction on movement of Goods Vehicles towards Kolkata and also within the Howrah Commissionerate area from 04:00 hrs. to 12:00 hrs. on 12.08.19 shall be as follows -

1. Nimtola crossing towards Bally along GT Road.
2. Ballykhal Island towards Bally along GT Road.
3. Bamundanga Island towards GT Road & Vivekananda Setu.
4. Nibedita Setu Northern Flank (Maitypara Crossing) towards Dakshineswar & Dunlop via Nibedita Setu.
5. Near Salap More towards Dasnagar along Howrah Amta Road.
6. Near Salap Bazar towards Dasnagar along Howrah Amta Road.
7. Kona More on NH6 towards Liluah along Benaras Road.
8. Kona More on NH6 towards Jagadishpur along Benaras Road.
9. Kazipara crossing towards Kolkata via 2nd Hooghly Bridge & towards Howrah via GT Road.
10. Coal Depot towards Howrah along Foreshore Road.
11. Toll plaza towards, Kolkata 2nd Hooghly Bridge.
12. Near Alampur More towards 2nd Hooghly Bridge along Andul Road.
13. Hansung crossing towards Drainage Canal Road & 2nd Hooghly Bridge.
14. Kona Truck terminal towards Kolkata & Howrah City along Kona Express Way & 2nd Hooghly Bridge.
15. Near Nibra More towards Kolkata & Howrah City along Kona Express Way & 2nd Hooghly Bridge.
16. Near IOC petrol pump at Jagadishpur on Benaras Road towards Kona Crossing along Eksara.

II. Diversion on movement of all classes of vehicles within the Howrah Commissionerate area from 06:00 hrs. to 12:00 hrs. on 12.08.19 shall be as follows -

1. From Sanpur crossing on Drainage Canal Road towards Bantra PS along Makardaha Road.
2. Howrah Amta Road & CTI crossing near Dasnagar I/C towards Bankra.
3. Salop Kaborpara towards Bankra on Howrah Amta Road.
4. From Garfa crossing along Kona Expressway up-to Sundarpara through Southern flank.
5. At Chatterjeepara crossing towards East West Bypass.
6. East West Bypass & Belilious Road X-ing towards Chatterjee Para.
7. Ashu Bose lane & Belilious Road X-ing towards Bantra PS.
8. Musalman-para lane & Belilious Road X-ing towards Bantra PS.
9. From Abani Dutta Road and Dobson Road X-ing towards Pilkhana X-ing.
10. M.S.P.C. Lane & Belilious Road X-ing towards Tikiapara.
11. Bata More towards Belilious Road.
12. From Bataitala towards Kazipara.
13. From Andul Road towards Carry Road on Kona Expressway and vice-versa.
14. From Andul Road & College Ghat X-ing towards Andul Road.
15. From Amtala TOP towards 2nd Hooghly Bridge.
16. At Banstala Ghat X-ing towards Kazipara.
17. At Telkol Ghat X-ing on Grand Foreshore Road.
18. From Santa Singh More towards Shalimar Road via Bharpara Road.
19. From Kazipara towards Foreshore Road and GT Road.
20. From Bankim Setu towards DM Slope and Foreshore Road.
21. From Fire Service Station towards Harimohan Bose Road and Fansitala.
22. From Abani Dutta Road and Dobson Road X-ing towards Golabari PS.
23. Diversion from Golabari PS towards Bandhaghat along Salkia School Road.
24. From Bandhaghat towards Salkia Chowrasta along Arobinda Road.
25. From Telkol Ghat Road towards Burn More
26. From Burn more to New Cab Road on Rishi Bankim Setu via DM slope and Rishi Bankim Chandra Road will be both way for the movement of all type of vehicles.
