Whereas it is necessary in the interest of public safety and convenience I, Gyanwant Singh, IPS, Commissioner of Police, Bidhannagar, in exercise of powers conferred upon me U/S 112 (2)/115/116/117 of Motor vehicles Act. 1988 Vide Notification No.813-WT/3M-80/2002 dated.09/03/2012 of Transport Department, do hereby issue the following restrictive orders on movement of Goods Vehicles in c/w Political Rally on 19th January, 2019 as per following time schedule on the following roads.

A. TIME & DATE

03:30 hrs to 22:00 hrs on 19.01.2019

MOVEMENT RESTRICTIONS

- 1. No Goods vehicle will be allowed to enter Jessore road from Belghoria Expressway and to move towards Kolkata in view of that a restriction point will be formed near Airport City Hotel.
- 2. No goods vehicle will be allowed to enter VIP Road (Kazi Nazrul Islam Avenue) from Jessore Road-VIP Road Crossing towards Ultodanga or EM bypass through VIP road in view of that a restriction point will be formed near Lake Town crossing.
- 3. No Goods Vehicle will be allowed to enter MAR (Biswa Bangla Sarani) and to move towards Chingrighata through MAR in view of that a holding point will be formed backside of Aliah University, New Town.
- **4.** No Goods Vehicle will be allowed to move towards Kolkata bound Jessore road from Sahara bridge.
- B. Perishable Goods Vehicles, Oil Tankers and vehicles carrying gas can enter Kolkata till 08:00 hrs on 19.01.2019 and later entry of those vehicles are also to be restricted.

These restrictions with remain in force in addition to the normal restriction on the day which is not repugnant to above.
