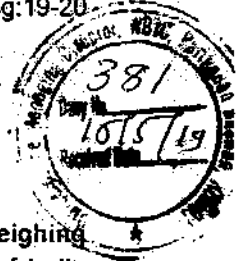

The above cargo would be transported by Hydraulic Axles with suitable Prime Movers as per MoRTH Guidelines.

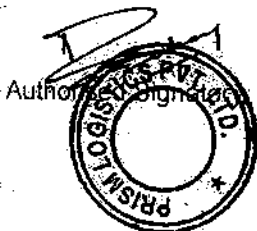
The said cargo would be entering into West Bengal from the border area of Dalkhola to move upto Barobisha for entering the state Assam.
