Whereas it is necessary in the interest of public safety and convenience in view of to ease traffic congestion on Jessore Road under PS Dumdum, to impose traffic restriction for regulating the movement of all types of vehicle under Barrackpore Police Commissionerate.

In exercise of powers conferred upon me under Section 115, 117, 122 & 126 M.V.Act 1988 & under Sub-Section(1) of Section(4) of West Bengal Traffic Regulation Act, 1965(WB Act XV of 1965) read with Govt. West Bengal Home (Transport Department) Order No. 7605-WT, dtd. The 20th July, 1965 and Govt. of West Bengal Transport Department Notification No. 3363-WT/3M-34/99, dtd. the 29th April, 1999, I, Dr. Rajesh Kumar Singh, IPS, Commissioner of Police, Barrackpore do hereby issue the following restrictive order as per following time schedule on the following roads.

- 1) No vehicle coming from Kumar Para Crossing through Italgacha Road will take right turn on Jessore Road.
- 2) Median Divider at Italgach Crossing on Jessore Road is being closed permanently.
