**TRAFFIC REGULATIONS**

Whereas it is necessary in the interest of public safety & convenience and to ease traffic congestion of Gopal Lal Thakur Road, Deshbandhu Road and Surya Sen Road (Alam Bazar) under PS Baranagar of Barrackpore Police Commissionerate by imposing traffic restriction to regulate the movement of all types of goods vehicle.

In exercise of powers conferred upon me under Section 115, 117, 122 & 126 M.V.Act 1988 & under Sub-Section(1) of Section(4) of West Bengal Traffic Regulation Act, 1965(WB Act XV of 1965) read with Govt. West Bengal Home (Transport Department) Order No. 7605-WT, dtd. The 20<sup>th</sup> July, 1965 and Govt. of West Bengal Transport Department Notification No. 3363-WT/3M-34/99, dtd. the 29<sup>th</sup> April, 1999, I, Sunil Kumar Choudhary, IPS, Commissioner of Police, Barrackpore do hereby issue the following restrictive order as per following time schedule on the following roads.

**Time:**

From 08.00hrs. to 12.00hrs. and again 16.00hrs. to 21.00hrs. every day.

**Type of Restriction:**

No goods vehicle will be allowed to ply on Gopal Lal Thakur Road, Deshbandhu Road and Surya Sen Road (Alam Bazar) under jurisdiction of Baranagar PS.


